1. Call to Order

The meeting was called to order at 5:02.

2. Review and Approval of Previous Minutes

- June and July 2025 minutes were reviewed.
- Motion to approve: Candice
- Seconded: Annie
- Vote: Unanimously approved.

3. Agenda Adjustments

- Board sheet/summary from John was removed as no summary was provided.

4. Action Items and Policy Approvals

The following items were individually motioned, seconded, and unanimously approved:

- 1. Service Animal Policy
- 2. Attendance Policy
- 3. Employee and Student Handbooks
- 4. Live Streaming Policy (authorizer request to begin recording and streaming meetings).

5. Finance Report (Chad)

- Reviewed FY26 budget adjustments.
- Enrollment reduced by \sim 2,000 students (flat year-over-year).
- Total funding reduced by \sim \$11.7M; now \sim \$18.9M.
- Teacher costs reduced by \$2.3M.
- Student-level costs decreased by \$6.2M; admin costs by \$2M; tech services by \$800k.
- Staffing: 101 FTEs projected for FY26 (vs. 76 prior year).
- Surplus projected: \$200k (down from \$300k).
- Current year update: July books closed.
- Projected enrollment $\sim 2,200$.
- Additional 3 FTEs added; total 104 FTEs.
- School expected to be financially break-even.

6. Leadership Updates

- Special Programs Coordinator: Introduction postponed until next month.
- Enrollment: Covered in finance update.

7. DCAP Update (Pam)

- All five DCAPs lifted major milestone.
- Ongoing oversight remains for PowerSchool (HS grades/transcripts), WIPs, and special education compliance.
- One update required by Oct. 15: WIPs for 69 seniors.
- Partnership with Cante and support from Chrissy has improved compliance.
- Board praised leadership team for significant progress.

8. Federal Programs Recognition (Brandy)

- Recognized by the district five times at the FY26 Federal Programs Conference.
- Commended for strong collaboration with finance, Epicenter compliance, and budgeting.
- Board congratulated Brandy for her leadership.

9. Hiring Update (Pam)

- Three positions currently open:
- 3rd Grade Math Teacher
- High School Social Studies Teacher
- High School Health CTE Teacher
- Coverage provided by shared teachers until hires are made.
- New teachers onboarding (some began this week, others starting Monday).

10. Community Outreach

- Recent event celebrated; Channel 57 covered the event.
- Board member Annie assisted with photos and represented parent learning coaches.

11. Executive Session

- Motion made and seconded to enter executive session to review preliminary results per authorizer's request.
- Approved unanimously.
- Only board members and Pam remained.

12. Adjournment

- Meeting adjourned following executive session.
